## Evidence of Financial Support for International Students

U.S. immigration regulations require nonimmigrant students seeking F-1 visa status to present proof of financial support to cover all study and living expenses for the first year of study. Privately sponsored students must submit a Declaration of Financial Support from the sponsor stating the amount that will be provided in addition to financial documentation. We cannot issue an I-20 Certificate of Eligibility—which is required for a visa—until we receive this documentation.

**Evidence of financial support may be submitted with the application for admission or after you have been admitted to the college.**

For students in all associate degree programs, except for direct admits to the nursing program:

For students who have been directly admitted to the nursing program:

### Additional Costs for Dependents

If your legal spouse and/or children will accompany you to the United States, additional financial documentation is required in the following amounts:

First dependent.....	\$5,500.00
Each additional dependent.....	\$3,000.00

You must also provide a passport and marriage certificate (for a spouse) and/or birth certificate (for each child).

### Acceptable Forms of Documentation

- Bank statements indicating type of currency
- Investment statements indicating liquid assets
- Scholarship letters
- Lines of credit
- Governmental funding

### Unacceptable Forms of Documentation

- Chartered account statements
- Payroll reports/expected income
- Tax statements
- Property assessments
- Credit cards
- Bank statements lacking type of currency

**Please note:** All financial documentation must be dated within six months of the date of submission.
